<b><i>“Cleaning up the Baldwin Park Operable Unit (BPOU)”</i></b>	Mr. Johnson made a presentation to the Board regarding the status of the cleanup in the Baldwin Park Operable Unit (BPOU). He reviewed all of the treatment facilities and the statistics for each one. He summarized that the new treatment capacity was 26,900 GPM. He noted that the partnership between responsible parties and water companies was to avoid litigation and minimize duplication of facilities, energy costs, and operation and maintenance costs. He also noted that the retention of treated water in the Main Basin was for potable use.


A Legislative Public Information Committee meeting was not scheduled at this time.
