<i>Approval of Letter Agreement between Central Basin MWD and WQA Regarding HR 123</i>	<p>Ms. Burgess reported that Central Basin MWD (CBMWD) had requested an amendment to H.R. 123 that would add an additional \$11.2 million authorization for the operation of its Water Quality Protection Project (WQPP). The letter agreement between WQA and CBMWD stated that WQA would receive 90 percent of the annual appropriation to the San Gabriel Basin Restoration Fund (Fund) for its various projects and that CBMWD will receive 10 percent of the annual appropriation to the Fund for the continued operation of the WQPP. Additionally the letter stated that CBMWD would be responsible for the 35 percent local cost share requirement for its annual appropriation amount up to its total authorized amount as well as any other costs directly or indirectly associated with the WQPP.</p> <p>Mr. Kuhn suggested that the chairperson from each Board sign the letter along with the General Manager and the Board agreed.</p>

After general discussion, Mr. Whitehead moved to approve the letter agreement between CBMWD and WQA regarding H.R. 123 with the noted changes. Ms. Montano seconded the motion and it was unanimously approved.
